# ACCOMMODATION BOOKING TERMS AND CONDITIONS

- Our accommodations are let out on a weekly basis from Saturday 4:00 P.M. to the following Saturday 10:00 A.M. for one week or more. If the stay wholly takes place out of the months of July and August, it is possible to book from an other day than the Saturday.
- The time between the preliminary booking and the receipt of the booking form by the campsite **with the down payment** shall not exceed one week. Otherwise the preliminary booking will automatically be cancelled.
- If you wish to change the dates of your stay, we cannot guarantee the same type of accommodation.
- The contract is non-transferable to third parties without prior written consent by the Campsite and only the persons who are inscribed on the contract can participate.
- In case you do not show up on the specified date agreed to in the contract, the accommodation can be reallocated 24 hours after the arrival date specified in the contract. The whole balance however will remain due.
- In case of delayed arrival or early departure no refund will be granted.
- **Should you cancel** the contracted stay :
  - More than 30 days before the expected arrival date :  
You would be charged only the compulsory booking fee and 25 % of the entire amount of your stay.
  - Less than 30 days before the expected arrival date or if you fail to appear on that date :  
You would be liable to pay the compulsory booking fee and the total cost of your stay.

However, **you can take out a payable cancellation insurance** for a fixed sum per booked week, by mentioning it on the booking form.

This insurance refunds the forfeit you would be liable to pay in case of cancellation of your stay, calculated according to our booking terms. It covers exclusively duly justified cases of absolute necessity. It can only be taken out for stays beginning more than one month after the booking.

- According to the French legislation, this booking is firm and there is no cooling-off period.
- You must have a civil responsibility insurance under way of validity.
- Guests have to comply with the **Rules and Procedures** of the campsite. A copy of these Rules is available on request. They are posted at the sanitary block and at the reception. Please take good note of the following :
  1. The reception has to be notified of any **visitors** as soon as they arrive. Their stay is not allowed to exceed one day and it is subject to a fee and to authorization.
  2. **Dogs and cats** are allowed on the Campsite - one pet per accommodation - provided that they are clean and constantly leashed. Their presence is subject to a fee. *You will be asked to produce valid rabies vaccination and tattoo or microchip identification certificates on your arrival.*
  3. Smoking is forbidden in the walled public areas and in the accommodation.
- The settlement of the balance of your booking is due **one month before arrival.**
- We accept the following **payment methods** :
  - Cash money
  - Bank cheque (only emitted from a French bank) made payable to : « Camping Le Moulin SARL »

- A **security deposit** will be collected on arrival. This deposit consists of :
  - An accommodation deposit of 200 € by check, cash or credit card intended to cover breakage or damage of the accommodation sustained during your stay. This deposit will be refunded on your departure after the accommodation has been checked.
  - Separately 50 € for possible cleaning expenses. This will also be refunded on departure unless the accommodation is not left in a satisfactory state or if you do not want to do the cleaning yourself.
- The accommodation prices include gas and water consummations.  
Electricity is included until 10kW.h per day, straight past it is invoiced 0.21 € per Kw.h.

This can only take place within the Reception opening hours. If you want to leave before or after this period, the deposit will be sent back to you within a month time provided the accommodation was left in a satisfactory condition.
- The French stay tax is included in the prices.
